
CONSENT JUDGMENT AS TO DEFENDANT DONOVAN DAVIDSON AND

CLAIMS AGAINST DONOVAN DAVIDSON

Plaintiff Thomas S. Richey, as Receiver for Weston Rutledge Financial Services, Inc., Zamindari Capital, LLC, Lexington International Fund, LLC, a/k/a Lexington International Fund, Inc., and Oxford Adams Capital, LLC (the "Receivership Companies") (the "Receiver") and Defendant Donovan E. Davidson's Motion for Consent Judgment and Dismissal Without Prejudice as to Defendant Donovan Davidson having come before this Court and having been read and considered, it is hereby ORDERED, ADJUDGED and DECREED that

1. Plaintiff be and is hereby awarded judgment against Defendant Davidson in the principal amount of \$613,208.04 on his claim of money had and received; and
2. The remainder of the Receiver's claims against Defendant Davidson be and are hereby dismissed without prejudice.

It is FURTHER ORDERED that a Writ of Execution issue forthwith against Defendant Davidson in the amount of \$613,208.04.
