CONSENT JUDGMENT ORDER
AS TO DEFENDANT EUGENE LEE MCCORD

The Motion for Consent Judgment filed by Plaintiff Thomas S. Richey, as Receiver for Weston Rutledge Financial Services, Inc., Zamindari Capital, LLC, Lexington International Fund, LLC, a/k/a Lexington International Fund, Inc., and Oxford Adams Capital, LLC (the "Receivership Companies") (the "Receiver") and Defendant Eugene Lee McCord came before this Court.

The Motion informs the Court, among other things, that


1. Plaintiff seeks a judgment in the principal amount of \$5,000.00 from Defendant McCord.
2. Defendant McCord denies any wrongdoing whatsoever and states that he did not knowingly or recklessly accept funds to which he did not believe he was entitled or engage in any wrongdoing at all. Defendant McCord maintains that he acted in good faith at all times.
3. Defendant McCord has agreed, however, in the interest of ending this litigation, and consents to entry of a judgment against him in the amount of \$5,000.00.
4. The Receiver has agreed and consents to entry of the proposed Consent Judgment in the proposed amount in complete disposition of his claims against Defendant McCord.

The Consent Motion having been read and considered, it is hereby ORDERED, ADJUDGED, and DECREED that Plaintiff be and is hereby awarded judgment against Defendant McCord in the principal amount of \$5,000.00.


